Responsibilities:

- Assist the Environmental Scientist with outreach, field installation of monitoring equipment, and educating community members for our citizen science monitoring programs;
- Properly use, maintain, and inventory monitoring equipment and technology;
- Assist in analyzing and comparing data to published research on air, water, and noise pollution;
- Assist in writing reports to residents and regulatory agencies;
- Assist in reviewing permit documents for compliance with state and federal laws;
- Contribute to public comments on permitting and environmental policy with other interns;
- Assist with and/or attend occasional evening and weekend events;
- Other tasks as needed

Qualifications:

- Working towards a Bachelor's or Master's Degree in Environmental Science, Biology, Chemistry, Geography, Natural Sciences, Geology, Computer Science, or related program.
- Proficiency in Windows operating systems, Google Workspace, and other online platforms
- Familiarity with Jupyter Notebooks and the Python programming language
- The ability to quickly learn and assist in educating others about citizen science monitoring programs
