Fracking Impacts Protective Buffers

The Marcellus shale industry has been allowed to drill dangerously close to Pennsylvania homes, schools, hospitals, and waterways for years. Dozens of scientific studies now confirm this has harmed our health and environment. It's past time for our government to update old laws, which never took public health into account. by requiring greater protective buffer distances to keep us safe. A coalition of nonprofits and resident groups, Protective Buffers PA, is petitioning for statewide minimum setback distances. Our petition has been tabled since April as we await completion of the

state's budget. The PA Environmental Quality Board met on September 9th, its first convening since our petition was heard and tabled for an indefinite future date. Two Marcellus Shale Coalition petitions were on the agenda for September, but these were postponed. DEP Secretary Jessica Shirley commented that the October meeting may feature three petitions. We hope the third will be ours. Email lauren@protectpt.org to join us for a day of action in Harrisburg on October 29th, 2025 to meet with legislators and deliver 1,000 postcards signed by PA residents asking for protective buffers!

Drakulic Well Pad Permits Expired!

On September 12, 2025, the DEP moved for the Commonwealth Court to declare Protect PT's pending Drakulic well pad permit appeal and associated history of litigation moot, as CNX did not begin drilling when the permits were granted by the EHB on June 3rd, 2025 and the permits in question have now expired. The ongoing litigation at the Commonwealth Court would have settled matters once and for all as to whether the Department violated the

law when it issued the permits. Instead, WCAA (CNX) could apply for entirely new permits to do the very same drilling, avoid complying with protective conditions the EHB added to the now-expired permits, and force community groups and local residents to restart the appeal process.

"It is 'radically transparent' that CNX would like to drain community resources while failing to comply with regulations by allowing these permits to expire while there is ongoing litigation, the outcome of which could have protected the health and welfare of our community," said Gillian Graber. It is critical that the DEP stop similar future permits at the same site from being granted, forcing perpetual appeals, expirations, and new applications.

Protect PT will continue its work to organize and educate area residents about the public health impacts of the Drakulic wells, and find a resolution that will keep fracking away from our local schools, homes, playgrounds, and places of worship for good.

Radon on the Rise The best time to test!

Even though it's invisible to the eye,

it's no secret that Radon Gas is harmful to human health as exposure is the leading cause of lung cancer in US non-smokers. While Halloween brings many myths and fables, myths about radon gas are easy to contest. Come by our table outside Penn Area Library on October 10th from 1 PM - 5 PM to speak to us in person, or attend our virtual October Lunch & Learn on October 28th at noon, to learn more about the effects of Radon and see if you are eligible for our free monitoring. Water Concerns Municipal Authority of Westmoreland County

Earlier this summer. Protect PT Community Advocate, James Cirilano, and Environmental Policy Advocate, Lauren Posey, attended a MAWC Board Meeting to advocate for stricter regulations surrounding the sale of water during periods of drought from the Beaver Run Reservoir to gas companies for fracking. Water that is used for fracking can never be used again, or ever returned to the water supply, due to radioactive contamination and chemical pollutants. MAWC has not yet taken up our suggested ban on water sales for fracking during drought and we continue to pursue this protection for residents. Learn more at protectpt.org/beaver-run.

At the last Penn Township Business Meeting, we got a first look at the proposed maps. There are designated "Mineral Overlay" zones where oil and gas development currently occurs and is limited to.

Other "Light Industrial Commerce" zones have been proposed, though what is allowed in the zones is still to be determined. Because of diligent participation by residents, progress has been made. While adjustments addressed concerns, we still plan to advocate for anyone who still could be affected by these changes. Please reach out to us if so!
