## Legal Updates

Metis and Gaia: The Pennsylvania Supreme Court accepted Protect PT's appeals 2 WAP 2021 and 3 WAP 2021 regarding the Metis and Gaia well pads in Penn Township, Westmoreland County. The appeal was accepted and will be heard on two issues. First, Protect PT asserts that the Commonwealth Court ignored the testimony of expert witnesses regarding the precautionary principle, a principle which indicates that if there is a chance an activity could have harmful impacts to public health, that activity should be stopped until scientific evidence proves that it is safe. Secondly, Protect PT questions whether the Commonwealth Court failed to evaluate the cumulative impacts of developing multiple unconventional natural gas wells in close proximity to residential neighborhoods that could alter the character of the community and jeopardize public health and safety. We are currently waiting on a date for the hearing before the PA Supreme Court.

Drakulic: We are still waiting on a date for our argument before the Environmental Hearing Board. We are arguing that the PA DEP abused its discretion by granting the drilling permit and failed to meet its obligations under Article I, Section 27 of the Pennsylvania Constitution. Section 27 guarantees all Pennsylvanians the "right to clean air, pure water, and to the preservation of the natural, scenic, historic and aesthetic values of the environment." The DEP failed to meet Section 27 requirements when they issued Apex two new well permits despite the fact that Apex did not have a complete and accurate emergency response plan (ERP) in place. Apex failed to identify risks and hazards within half a mile of the well site, risking residents' health, safety, livelihood, and home in the situation of an evacuation. Additionally, DEP issued these permits with full knowledge of Apex's ongoing violations at other unconventional well sites, including the Fatur well site in Salem Township.

# Radioactive Waste Impacts Residents Near Local Landfills

The waste materials generated from fracking contain radioactive elements and pose significant risks. In Pennsylvania, fracking waste has been disposed of in municipal landfills for more than a decade. In Rostraver Township, the Westmoreland Sanitary Landfill has plagued local residents for years. Last fall, Protect PT mailed a survey to 7,000 residents around the landfill and over 170 responded. Their responses highlighted impacts like health problems, sludge on roadways and vehicles, horrible smells, concerns about air and water quality, and more. Even more alarming, the Westmoreland Sanitary Landfill applied for a permit with the Department of Environmental Protection to evaporate the leachate (landfill tea or liquid runoff) from their site. This would propel harmful constituents into the air, further impacting the surrounding community! **Protect PT is hosting a Community Meeting for neighbors of the landfill March 25 @ 6:30 pm.** This meeting will give residents the opportunity to voice their concerns directly with PA DEP and discuss next steps in establishing better protections for residents.

## Waste Injection Well Threatens Region's Drinking Water

Municipal landfills are not the only dumping grounds for radioactive fracking waste. Fracking waste is also being pumped into the ground with injection wells like the Sedat 3A Injection Well in Plum, scheduled to begin operation in March. The Plum well was originally designed in the 1980s as a conventional gas well but remained unused until Pennoco applied for the permits to use it as an injection well. Injecting waste at this particular site poses significant concerns of water contamination since the well is located very close to the Allegheny River, upstream from the water intake for the Pittsburgh Water and Sewer Authority (which provides drinking water for the City of Pittsburgh and surrounding areas). Protect PT, along with Citizens 4 Plum, and the Breathe Project, wrote a letter to Governor Wolf, asking him to revoke the permit. Several organizations and community groups signed the letter.
